### Consent Form

By signing this consent form, I acknowledge and agree to all terms listed below:

- Participation:** The competition is open to all contestants between the ages of 12 to 18 years old, i.e. born between the dates March 7, 2003 to March 6, 2010 (The contestant's age is determined on March 6, 2022 which is the first day of the competition). Admission to the competition is conditional on paying an admission fee.

- Potential Changes:** The Raanana Pais Music Center reserves the right to change aspects of the competition including rules or repertoire, without prior notice. All changes and updates will be posted on the competition website.
- Recording Performances:** Contestants are allowed to record their own performances using recording devices, but are not allowed to post and/ or share the recordings on any social media or messaging platform during the competition period.  
The Raanana Pais Music Center has the right to record contestants' performances (audio, video photography, still-image photography) and to make use of the recordings, visually photographed portrait or image and/or video in any way it deems, during the competition and after the competition. All recordings made by the Raanana Pais music Center are the sole property of the Raanana Pais Music Center, and could be used for the specific purposes of publication in print or electronic documents, books, flyers, promotional tools, magazines, newsletters, websites, social media and other platforms of a similar nature. The contestant will receive no compensation for the use of any recordings of the contestant by The Raanana Pais Music Center, and indemnifies the Raanana Pais Music Center from any and all claims resulting from the use and/or publication of any of the contestant's forms of recordings by the Raanana Pais Music Center and/ or its third party affiliates.
